  - (c) The TEXMiN reserves the right for an exceptionally meritorious candidate, the selection/scrutiny committee may relax the essential experience.
  - (d) The TEXMiN reserves the right not to fill up the positions, cancel the Advt. inwhole or in part without assigning any reason, and its decision in this regard shall be final.

(e) All advertised positions are purely temporary and contractual in nature, and the selected candidates cannot claim for appointment against any regular positions in the Institute/ TEXMiN. (f) The engagement of all advertised positions will be subject to their medical fitness and Police Verification.
